This application must be signed under oath in the presence of a notary public and submitted to the County Clerk at least 5 days prior to the meeting of the legislative body at which it is to be considered. Once elected, you will be commissioned by the Governor. If elected, you will be required to post a bond in the amount of \$10,000. The bond must be filed in the office of the County Clerk. You are not authorized to act as a notary public until you have received your commission from the Governor, filed your bond, and taken your oath of office. If you move our residence or principle place of business out of this county, you are required by law to notify the County Clerk of the change of address.
